RE: Other issues I have been dealing with.

Dear Ms. Elliott

After you read my letter to Dr. Michael Sherar asking about what he would propose the meeting be about, I would very much appreciate your advice on how I should approach this meeting, and whether I should have someone attend with me.

1. You were aware that I was threatened by CCO Senior Administration and thus ultimately by Senior Administration at Thunder Bay, entirely inappropriately by my colleague that if I continued to discuss these issues with patients and physicians that I would not longer be able to work in Thunder Bay.
 - On my last locum visit to Thunder Bay May 1-5, Dr. DOCTOR, a SPECIALIST, but also a CCO representative met with me.
 - He seemed to make it clear that not only was I not to speak with physicians or patients about the controversies surrounding PET:
 - ***But implied clearly that I would not even be allowed to use patient examples from Thunder Bay, EVEN IF THERE WAS NO WAY OF DETERMINING WHETHER THE PATIENTS WERE FROM THUNDER BAY OR NOT!***
 - ***BUT, he also emphasized, that CCO encourages ME TO CONTINUE MY EFFORTS TO ADVOCATE FOR PET!***

2. One issue you may want to also consider looking is that Dr. DOCTOR, acting only in an administrative fashion knew the patient had been determined to be Stage IV even before the patient or I did! There is a possibility of a serious breach of Dr. DOCTOR's inappropriate access to her file.

In my letter to Dr. DOCTOR, I asked him about this.

- ***True to 'boiler plate' CCO responses to questions, he did not answer a single question I asked him.***

MY SUBSEQUENT ACTIONS AND RESULTS:

As you may be aware based on material sent to Ms. Wasserman and subsequently, Mr. Mondszein, that I wrote the Chairman of the Board for Cancer Care Ontario as well as several communications with Dr. Robin McLeod, Vice President Clinical Programs and Quality Initiatives Cancer Care Ontario. I have also copied letters to Dr. Michael Sherar the President and CEO of Cancer Care Ontario.

1. I received a 'registered letter' from Mr. Ralliaram stating that the Senior Executive would be looking into the issues. I sent a subsequent letter after learning what had now happened to Carol.
2. Dr. Sherar has asked to meet with me in person. This clearly indicates that I have 'their full attention'. However, this may not be a good thing for me personally. I will include my letter to Dr. Sherar asking him to be clear about what he would like to discuss, and who would be present.
3. I did receive a letter to me from Drs. McLeod, Metser, and Dobranowski about Carol. As expected, they simply 'puff out their chests' about their efforts, but refuse to address a single question of relevance, and have dismissed Carol's concerns. This letter and my response will also be appended to you and Mr. Chris Mondszein for his files.
